When completed, PRTC customers in communities like Hickory Tavern, Waterloo, Enoree, Gray Court, Ora, Laurens, and western Laurens County will have access to the Internet via some of the most state-of-the-art telecommunications infrastructure available.

Our customers also enjoy the benefits of being part of a cooperative where we return part of our profit back to our customers. This past year, we issued close to \$1 million in capital credit checks to you, our faithful customers.

Mr. Branyon referenced our multi-phase fiber optic cable build out in his message, and I want to emphasize the importance of making this investment for our cooperative members. Replacing our copper cable network with fiber cable technology enables many advanced applications like telemedicine, long distance learning, work from home capabilities, and emerging agriculture technologies.

Telemedicine allows doctors to share medical images, records, and documentation with other medical experts anywhere in the world in order to improve medical treatment and diagnostics. Distance learning affords children the opportunity to access learning and degreed programs from educational institutions outside of Laurens County and is now possible thanks to our enhanced Internet capability. Work from home is also a reality for our cooperative members as a result of the increased capabilities over fiber optic cable.

Agriculture is very important to our area, and our network investments will allow us to take advantage of new and emerging agriculture technologies that assist farmers and ranchers. These Smart Farm applications utilize the Internet to improve yields and food quality by monitoring physical conditions, soil quality, and timing of feed and water, for example.

These are just some of the benefits of our network investments for our cooperative members. However, our greatest asset is, and always will be, our employees. We are your friends, neighbors, and fellow church members. And we're here every day to provide a level of service that other telecommunication companies in the area just can't match.




